Brian B opened the meeting with the Serenity Prayer.

<u>Secretary's Report/Minutes</u>: **Motion** and **second** to approve August 18, 2025, minutes as submitted, all in favor.

He did present the idea of preparing themed QR Code flyers (ex: newcomers) as a PI tool to New York GSO. All new pamphlets from New York will feature QR codes that take you to a pdf version on the GSO website. He noted anyone preparing this type of handout should probably use the QR codes provided by New York as opposed to creating new ones.

Accessibility Committee: Dave Y All Accessibilities Committee: Monday, September 8th 2025

- An ASL interpreter is currently used at this meeting. The group conscience opted to include a
 professional Spanish interpreter, who is also an alcoholic.
- Josh R, developer of the Meeting Guide app, spoke on "Helping to Find AA Meetings"
 - Josh launched the Meeting Guide app in 2015 and donated the rights to AA World Services in 2018. It is now used by 556 service entities. It updates every 12 hours, works with screen readers, adapts to phone text size and dark/light mode.
 - Different types of meetings can be selected, including handicap accessible, restroom accessible, and ASL interpreters.

- General Services (GS) reviews and looks for gaps by seeing what local orgs use on their websites. Local sites are encouraged to propose new meeting types. Looking for feedback on the good and bad features. GS reviews suggestions and forwards to Code4Recovery to make the changes. (To submit feedback: At the bottom of the app: Select Contact. Under Help & Feedback, Select Make a Suggestion for the App. Feedback goes to General Services Code4Recovery via app's Help & Feedback → Make a Suggestion.)
- Selecting the Online Support site opens a browser to information about the Meeting Guide and for the local web admins, with instructions on how to connect their meeting database to the Meeting Guide.
- Upcoming Meeting Guide feature from National AA Technology Workshop (NAATW): An ONLINE meeting tab at the bottom. It first sorts by time of day then by distance. Users can sort on a meeting type (Ex: ASL).
- AA Online Intergroup list not currently connected to the Meeting Guide.
- "12 Step Meeting" WordPress plugin used by AA websites mirrors the Meeting Guide and is mobile friendly.
- Josh urged local sites to conduct accessibility audits.
- David Y purchased Accessibilities related pamphlets for \$203.38 and distributed them to:
 - Solomons Nursing and Rehab Center, Solomons
 - Asbury, Solomons
 - Calvert Pines Senior Citizens Center, Prince Frederick
 - North Beach Senior Center, North Beach
 - Southern Pines Senior Center, Lusby

The contact at Solomons Nursing and Rehab Center, Deci, asked about bringing a meeting into the center. She will poll the residents during an upcoming group meeting. She says there are some that need AA, but she's not sure if they will be receptive.

Brian B asked if SMIA has an Accessibilities Chair. Lorraine reported that they do not.

Lorraine J will advise **Bill L** of the request for accessibility audits and asked if this information could be made available prior to the monthly SMIA meetings held on the second Saturday of the month as it might be of interest to that group.

Bridging the Gap: Chair Dave Y – Still no activity related to this position. He hasn't done anything further on developing a business card-sized handout with links to resources for individuals leaving treatment. **Kenny G** advised that he has given David's contact info to several clients leaving Avenues.

Events: **Jerry C** not present. Flyers for Chili Cookoff were distributed.

<u>Grapevine Committee</u>: John B – October issue features stores about technology in AA. Check the Grapevine website for more information and resources. They are still looking for stories from various sectors and jokes are always welcome. (After all, we are NOT a glum lot!)
